



Franklin County Equestrian Club 2017 Sanctioning Guidelines

1. Sanctioning Fee: **\$30.00** for one day show and **\$55.00** for two day show. Only one show sanctioned on a given day.
2. Priority is given to previously sanctioned shows for the corresponding weekend of a new year when possible. Dates are **only reserved until March 1st** without payment.
3. The description of classes in show flyer must match exactly the wording shown on the attached page. Sanctioned classes must be listed with FCEC.
4. The show manager shall email an electronic copy of the program to the FCEC sanctioning contact at least 30 days prior to the show date so it can be checked for appropriate FCEC class designation and posted on FCEC website.
5. Flyer must be approved by FCEC prior to being distributed. Once the flyer has been approved and distributed NO changes are allowed involving FCEC classes.
6. Results including class description, horse name, and rider name must be mailed (or emailed) to the FCEC point keeper **within two weeks** of the show date.
7. Sanctioned classes are open to anyone, but in order to receive points for the FCEC rider must be a member of the FCEC prior to the beginning of the show.
8. FCEC members will be issued back numbers beginning with 8000 and shall be worn by the declared horse/rider combination at FCEC shows/sanctioned shows. With the expectation any horse/rider combinations that have been declared by BRHF member would default to the BRHF.
9. Sanctioned classes can be split as long as the same horse/rider combination cannot ride in both classes.
10. Show managers are responsible for ensuring all classes are run in accordance with the 2017 FCEC Rule and Divisions descriptions.
11. Safe and adequate parking and footing are required at all facilities. A site visit by a FCEC board member may be required.
12. Shows not following these guidelines may not be sanctioned in the future.
13. **The FCEC Board of Directors reserves the right to refuse/revoke sanctioning for any show.**
14. FCEC classes are listed on the next page wording on show flyer must match the class list.
